Hearings and replies

- KD replied to what UiODoc wrote check document sent by Eirik.
- Tjenstemansloven replaced by the new law on governmental employees as of 1st of July 2017.
- Government can hire you up to 3 years, with contracts lasting between 6 months and 3 years. After that, they should give you a permanent position if you had cumulated 3

years in total. PhDs and Post-docs are special cases of employment.

- Question: What about the continuity of those 3 years, if in between one takes a PhD?
 2 years + 1 year for temporary employment (for PhDs)
- Postdocs: you can be hired up to 4 years. In NTNU, there are new policies, what a Postdoc is. At NTNU- After 3-4 years, they can hire you as a professor or researcher. They are running some pilot "plans", where they encourage the employees (including temporary employees) to take pedagogical courses, career evaluation etc. – they can eventually hire you. They try to avoid having people "stuck" there. They want to have competitive post-docs. Needs to be considered.
- Gray zone: Post-docs cannot do another PhD. Post-doc is a special position A sideeffect for the law – a clear definition of what the post-doc is;
- Do we get the seniority from the PhD?
- 3 years \Box 1.5 years seniority \Box from UiODoc
- A 3-4 year contract \Box will give 2 years of seniority UiODoc proposal
- Mobility advantages?
- International PhD seniority is calculated from the same employee (Norwegian government)
- Seniority from other countries should be counted, but it's hard.
- Leave without pay you keep your seniority from before, but you don't accumulate seniority from before.
- Parental/maternal leave they do not renew your contract. You have to quit when your contract ends.
- Post-docs position they should give you a 6 months position probation period before giving you a permanent position.
