1. Overview

The last Annual General Meeting (AGM) was arranged by UiODoc, and held the 23rd May 2013 at UiO in Oslo. This annual report covers the period since the last AGM.

Since the last AGM SiN has arranged 6 board meetings and 1 workshop. SiN has replied to 2 hearings from KD, participated in a UHR working group, arranged a meeting with NSO, held presentations at 2 events, and applied for financial support from KD.

In 2013/2014 SiN was represented at a national level in the board of the Research Committee of UHR, and at a European level by participation in EURODOC AGM. SiN was also present at major national events concerning research politics in Norway.

This board period SiN has focused on increasing its visibility and representation in research politics at a national level. We hope that the new board will continue this work and ensure SiNs representation in working groups, meetings and seminars with relevance to PhD candidates and PostDocs in Norway.

4. Main activities 2013/2014

In 2013/2014 SiN has:

- Arranged 6 board meetings on skype and one board meeting/workshop at UiO.
- Been represented at a national level through a board position in the Research Committee of *The Norwegian Association of Higher Education Institutions (UHR)*.

- Been represented at a European level by participation in *EURODOC AGM* and in *EURODOC Working groups*.
- Given its official opinion on matters important for PhD candidates and PostDocs in Norway through replies to the hearings *Long-term plan for research and higher education* and *Introduction of Tenure Track Positions*.
- Participated in and voiced its opinion in a working group on *Attractive career paths and increased mobility in research* in UHR.
- Given help and support to start a new PhD-organization at *the Norwegian School of Sports Sciences (NIH)*.
- Arranged a meeting and discussed possible collaboration with *the National Union of Students in Norway (NSO)*.
- Participated in several meetings and seminars regarding research politics in Norway.
- Sent an application for financial support to *the Ministry of Higher Education and Research (KD)*.
- Worked on increasing its visibility through more active use of Facebook and Twitter and by presenting the organization for PhD candidates.
- Done major revisions to the statutes and made a proposal for new statutes.
- Updated the document on internal regulations and organizational structure.

5. Board meetings and workshop

All SiN board meetings have been arranged on Skype in order to avoid travelling and save money. The board meetings was used to discuss the official opinion of SiN, prepare replies to hearings and working groups, share experiences from the local organizations and organize representation at important events.

SiN arranged a workshop at UiO in the beginning of March 2014 to finalize the application for financial support that was sent to KD on the 15 of March 2014.

6. SiNs website and social media

Ahmet O. Tezel was responsible for the SiN website in 2013/2014. The new wordpress website has been used, <http://stipendiat.no/wordpress/>. The website has been updated with information about the 2013/2014 board and the minutes from the meetings. However, the activity on the website has been low, and nothing has been posted throughout the year.

The SiN facebook-page has been managed by Marte C. W. Solheim and is currently managed by Izaskun Muruzabal-Lecumberri. The page now has 180 followers, compared to 100 followers at the beginning of the board period. The Twitter account has been managed by Ricardo Rosario, former member of SiN.

7. Representation

SiN has been represented at a national level by a board position in UHR FU, and by being present at major events related to research politics in Norway. SiN was also present at the EURODOC AGM.

- Hege Rudi Standal has been SiN-representative in the board of the *Research Committee of UHR* (The Norwegian Association of Higher Education Institutions) and in a *Working group on Attractive career paths and increased mobility in research*.
- In August 2013 SiN was represented by Erlend Dancke Sandorf and Pål Preede Revheim at *Nasjonal Forskerutdanningskonferanse 2013* (National Research Conference 2013) arranged at UiA.
- SiN was invited to hold a presentation at *Forskerforbundets Stipendiatseminar* (Seminar for PhDs arranged by the Norwegian Association of Researchers) in October 2013. Marthe Emelie M. Buan represented SiN and presented the organization.

- SiN arranged a *meeting with NSO* in Oslo in November 2013 where possible collaboration was discussed. Pål Preede Revheim and Marthe Emelie M. Buan represented SiN at this meeting.
- SiN invited itself to the *board seminar arranged by KD* in November 2013. Marthe Emelie M. Buan and Hege Rudi Standal were the official SiN representatives at this seminar.
- NIH contacted SiN through Ricardo Rosario to get support and help with starting a new PhD-organization. Marthe Emelie M. Buan went to the *start-up meeting at NIH* in March 2014 to give a short presentation of SiN.
- SiN was invited to send two representatives to the *EURODOC AGM* in the end of March 2014. Erlend Dancke Sandorf and Marthe Emelie M. Buan represented SiN at this event and also joined several working groups organized by EURODOC.

8. Replies to national hearings

During 2013/2014 SiN replied to 2 hearings from KD:

- 14th October 2013 - Innspill til Regjeringens langtidsplan for forskning og høyere utdanning 2015-2024. SiN was invited to send a reply to this hearing.
- 31st October 2013 – Endring i Universitets- og Høgskoleloven: Innstegsstilling – ansettelse på innstegsvilkår (§6-4). SiN was not invited to send a reply to this hearing. The reply was sent in collaboration with UiODoc since they arranged a discussion concerning the proposed tenure track positions in Norway.

9. Finance

In 2013/2014 Muhammad Ramzan has been the treasurer of SiN.

The Annual accounts contain transactions done from the 23rd of May 2013 to the 30th of April 2014.
