6. Position statement on Movement for a free academia (Karl Henrik).

a. What should be SiNs opinion on the movement?

Importance of being aware of the hierarchy in academia, to prevent abuse of power, to facilitate the purpose of truth, which should be the main objective of academia. There are often other purposes than truth seeking in academia.

Consultation statement: There is some frustration of members because of not having enough resources. Some feel like that a lot of time was spent on criticizing the new language requirements, without it bearing a lot of fruits.

7. Financial matters (Abdo)

a. Change the structure of compensation

We have money left on representation and conferences. We can take money around in different categories, apart from the compensation.

This year, to simplify things, Abdou suggests that the number of hours will be averaged and compensation shared between members, except from Ingvild who will be paid double since she worked more (divided 2 to 1). Board members agree.

b. Increase the compensation from 175 000 to 200 000

The compensation amount needs to be voted for at the AGM. Changing the compensation would need to get a vote from the local organization. It is however not easy to ask for more compensation.

c. Current financial account. How should we spend the money (all board members). AGM

We should spend more money on the AGM this year as well. It would be nice to have another board meeting, but capacity is quite limited right now. We should also spend as much as possible, otherwise the government might be giving less money the next time.

If we want more money, we have to show more than we need it. Something that can be presented at the AGM (projects for next boards): thinking on how to organize SiN, making me look more like NSO.

We need to spend 170 000 kroner. We should first sort out on AGM budget, then physical board meeting and then compensation.
